

SUMMARY ANNUAL REPORT FOR THE FIDELITY BANK GROUP LIFE & AD&D PLAN

This is a summary of the annual report of the THE FIDELITY BANK GROUP LIFE & AD&D PLAN (Employer Identification Number 56-0132040, Plan Number 506) for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has an insurance contract with SUN LIFE ASSURANCE COMPANY OF CANADA to pay certain Life insurance and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$163,487.
